**350 DECLARATION OF INTERESTS**

No Member made any declaration of interest in any item of business on the agenda.

**351 MINUTES OF THE PREVIOUS MEETING (13 DECEMBER 2010)**

**352 PUBLIC QUESTION TIME**

In accordance with the Parish Council's Standing Orders, a period of 10 minutes was allocated for members of the public to ask questions. Two members of the public were in attendance and raised matters in respect of a proposal to develop an area of land on Parkers Road.

Arising out of discussion, it was agreed that a representative from Bloor Homes be invited to a future meeting of the Parish Council.

**353 POLICE MATTERS**

There were no police matters to report.

**354 MATTERS RAISED BY PARISH COUNCILLORS**

Mr D Preece: Request for Grant from representatives of the Peer Mentoring Programme, Leighton Primary School. This matter had been deferred from the previous meeting.

**RESOLVED:** That a donation of £500 be made to Leighton Primary School to fund its peer mentoring programme.

**355 FINANCIAL MATTERS**

**355.1 Budget Proposals – 2011-2012**

Members considered an updated budget proposals report for 2011-2012 and were invited to set its precept for the following year.

It was agreed that Line 23 (Speed Watch Scheme) be increased from £10,000 to £11,300. The Clerk's salary remained unaltered at £3,162 pa. No other amendments were made.

**RESOLVED:** That the Clerk be authorised to request a precept of £22,000 from Cheshire East Council to fund its budget proposals for the year 2011-2012.

### **355.2 Authorisation of Payments**

**RESOLVED:** That the following payment be approved –

£131.27 Mrs C M Jones – claim for travelling expenses for the calendar year 2010.

Church Minshull Vernon Parish Council had submitted a request to hire/borrow the trailer-mounted unit, subject to satisfactory insurance/security arrangements being made. Subsequent to this item being included on the agenda, further information had been received and it was now understood that Church Minshull Parish Council was now making its own arrangements to purchase its own equipment.

The Clerk was asked to make enquiries.

### **357 UPDATE ON PROJECTS/STANDING ITEMS**

#### **357.1 Speed Watch Scheme/Traffic Management**

Mr Les Horne reported on recent activities under the Speed Watch scheme and the new Traffic Management Scheme.

During discussion of road safety, comment was made that either a street light, or a light within the church grounds at the entrance to the car park, would be beneficial to users of the church and the community hall. Mr Hollinshead undertook to raise this matter with the Parochial Church Council. An alternative would be for the Parish Council to consider funding the installation of a street light in 2012-2013.

#### **357.2 Local Area Partnership (LAP)**

The Parish Council was updated on a recent LAP meeting.
